

# INTERNATIONAL AGREEMENT OF APPROPRIATE USE UNIVERSITY AFFILIATE GROUP

# INTERNATIONAL AGREEMENT OF APPROPRIATE USE UNIVERSITY AFFILIATE GROUP

#### **TERMS OF AGREEMENT:**

### 1. Relationship between Society of Women Engineers and International Affiliate

The International Affiliate acknowledges that it is neither a subsidiary nor an agent of SWE and that this Agreement does not grant International Affiliate any right to represent itself to any third party as the agent of SWE or to incur legal or financial obligations on behalf of SWE, its Partners or any other Affiliates.

#### 2. <u>Accreditation and License</u>.

## a) <u>License; Conditions</u>.

### b) Ownership of Society of Women Engineers Logo and Marks.

The International Affiliate acknowledges that SWE is the exclusive owner of all SWE Marks, inclusive of any marks incorporating all or any portion of any Licensed Mark, and agrees not to take any action that would interfere with or dilute SWE ownership of or rights to any SWE Mark or with SWE's right to determine whether and how any SWE Mark or other intellectual property owned by SWE is used by third parties.

#### d) <u>Accreditation Period</u>.

The Accreditation Period shall be from today's date \_\_\_\_\_ until 30 June 2017, unless otherwise specified or sooner terminated by either party via written consent.

The International Affiliate shall adhere to the business regulatory requirements of the Area and shall consistently conduct its affairs in compliance with all laws, codes, rules, regulations and statutes.

The International Affiliate shall indemnify, defend and hold SWE, its officers, directors, members, employees and agents harmless from any claims, including costs and attorneys' fees, which the other party may incur arising out of the actions or omissions of the International Affiliate, and its officers, directors, members, employees and agents. This provision shall survive the termination of this Agreement.
